TOURNAMENT REGULATIONS

- **Time Control:** 3 min + 2 sec
- **System of Play:** The tournament will be conducted as per FIDE laws & Swiss system with 9 rounds.
- **Tie Break:** Latest Tie Break System will be followed
- **Protests:** Protests, if any against the decision of the Chief Arbiter shall be made in writing with a protest fee Rs.500/- within 5 minutes of the occurrence of the incident to the appeals committee. The protest fee will be refunded if the appeal is upheld.
- **Withdrawals:** A player may withdraw at any stage of the event after informing Chief arbiter in writing.
- **Appeals Committee:** Five members appeals committee shall be formed. No member of the committee can vote on dispute in which a player from himself is involved and in such cases, the reserve can take his place in the committee.
- Players qualified for more than one prizes will be considered only for higher prize.
