RULES AND REGULATIONS

As per AICF Regulations	 Players who finished first or second in any rating restricted tournament will not be eligible to play in any rating restricted tournament for one year from the date of such achievement The earlier rule of threshold of 36 months remains the same (once the player crosses the rating threshold he cannot participate for the event below that rating level for next 36 months).
System of Play	The Latest FIDE Rules in force shall apply and the Swiss system will be followed.
Mode of Tournament	Total nine rounds shall be played.
Time Control	30 minutes + 30 seconds increment per move from move no.1
Default time	Default time is 15 minutes. Players have to be at the boards within 15 minutes from the start of the round.
Tie break	Buchholz tie-break system will be applied. In case of tie, prizes will not be shared.
AICF Player Registration	AICF player registration is compulsory for all Indian players. AICF Player Registration fee is Rs. 300/- for the year 2025-2026. As per latest AICF regulation dated 31.07.2017, it is informed that from 01 September, 2017 all AICF registrations will be accepted only through online. Players / Arbiters registration should be done well before the start of event (Tournament). New entrants to the field of chess are informed that AICF players registration is mandatory and it should be done well before participating in any tournament. For renewing AICF registration of existing players, please click http://aicf.in/players/For fresh AICF registration please click http://aicf.in/online- player-registration/ For fresh AICF registration, players are requested to keep their scanned passport size photograph and birth certificate and a valid email address (unique) not used by any other person/ player for AICF, ready before the registration process. Note: Only passport size (less than 1MB) photographs in jpeg format should be uploaded.
TNSCA Player Registration	TNSCA player registration is compulsory for all Tamil Nadu players. TNSCA Player Registration fee is Rs.150/- for the year 2025-2026. Players / Arbiters registration should be done well before the start of event (Tournament). New entrants to the field of chess are informed that TNSCA players registration is mandatory and it should be done well before participating in any tournament. For renewing TNSCA player registration of existing players, please click https://registration.tamilchess.com/. For fresh TNSCA registration please click https://registration.tamilchess.com/new-register/ For fresh TNSCA registration, players are requested to keep their scanned passport size photograph and birth certificate and a valid email address ready before the registration process. Note: Only passport size (less than 1 MB) photographs in jpeg format should be uploaded

Chennai District Player Registration	Chennai DCC Registration fee is Rs.75/- for the year 2025 – 2026 (for Chennai district players only)
Protests	Protests if any, against the decision of the Chief Arbiter shall be made in writing with protest fee of Rs.1000/- within 15 minutes of the occurrence of the incident to the appeals committee. The protest fee will be refunded if the appeal is upheld.
Appeals Committee	Before the commencement of the Tournament, appeals committee will be formed from the senior participants present at the players meeting. The appeals committee decisions will be final and binding on all players concerned.
Withdrawals	A player may withdraw at any stage of the event, after informing the chief arbiter in writing
Last date	Entries close at 6.00 P.M on 11-11-2025
Rights of admission	The AICF/ TNSCA/ CDCA / organizer Eight Square Chess Academy reserve the rights of admission to the venue.

Wrist watches	AICF has banned the wrist watches while playing in FIDE Rated events. Players are instructed not to wear any kind of wrist watches while playing.

The Tournament Director has every right to make any addition/deletion/amendment to these rules.
